2. TRANSCRIPT

Attach a copy of your current full transcript. A full transcript should include ALL OF YOUR GRADES up to the most current quarter or semester FROM EVERY YEAR YOU HAVE ATTENDED YOUR SCHOOL. If you are attending the school for the first time, please use your full transcript from your previous school.

For example, a freshman in high school in their first semester would attach a transcript from middle school with grades from sixth grade through eighth grade. A sophomore who transferred would submit transcripts from both schools. A junior would include a transcript with all grades from freshman year through junior year.

3. FINANCIAL AID APPLICATION

To apply for financial aid to our program, we request that you submit a copy of your most recent Income Tax Return. We require financial information forms every year so we can maintain current information.

The Academic Year Program tuition for Middle School is \$3000. For 9th, 10th and 11th grade it is \$3500, and for 12th grade it is \$4500. Summer Academy Tuition is \$2000 with the exception of rising seniors, for which it is \$2500. 98% of our students receive financial aid to attend our program.

We have tried to anticipate questions you might have applying for financial aid, but please feel free to contact us if you have other concerns:

Why does NGS need a copy of my family's tax return?

Next Generation Scholars operates on a sliding scale. The financial information allows us to determine if you are eligible for a full scholarship or reduced cost for the program.

Will my information be confidential?

Absolutely! Your information will only be viewed by the committee that determines financial aid eligibility for the program. Information on the income levels of the students is only reported for the group as a whole and is always anonymous.

If my financial status has changed, what happens next?


If you previously qualified for a full scholarship, but are no longer eligible, we will use a sliding scale to determine the cost for the program that is within your means. We will present different options available and allow you time to make a choice before deciding to enroll.

If my family does not have a tax return, can I still apply for financial aid?

Yes, you may submit pay stubs, a letter from an employer stating income, proof of free and reduced lunch, or proof of foster care, shelter residence or subsidized housing.


4. PERSONAL STATEMENT
